Use

For cleaning and passivating aluminum and aluminum alloys.

Description

Semco[®] Pasa-Jell 102 and 102-M are blends of mineral acids, activators, and inhibitors. They do not contain fluorides and can be used in applications where fluorides are prohibited.

Semco[®] Pasa-Jell 102 and 102-M are designed to clean and passivate aluminum and aluminum alloys. They accomplish the passivation by removing foreign materials and corrosion products that could set up local cells and cause pitting corrosion, and by forming an extremely thin but corrosion-resistant adherent oxide film on the metal.

Semco[®] Pasa-Jell 102 and 102-M can also be used to remove anodized coatings from aluminum, although it does not act as rapidly as Semco[®] Pasa-Jell 101. When spot removing anodized coatings, it will stay in place without running onto adjacent areas.

Application

Remove oil or grease by wiping with an oil-free solvent (do not use reclaimed solvents) or by other effective methods. Allow the surface to dry. Apply Semco[®] Pasa-Jell 102 in a thick layer with a polyethylene, polypropylene, or fluorocarbon bristle brush. The coating should not be so thick that it will sag. Allow coating to set for 20 to 30 minutes and then rinse with cool tap water. Allow the surface to dry. The time required to remove anodized coatings will vary somewhat with the thickness, type, and age of the coating. Heavy corrosion or old, thick anodized coatings may require an application of Semco[®] Pasa-Jell 101 prior to passivating with Semco[®] Pasa-Jell 102.

On copper bearing aluminum alloys, a dark smut may result if Semco[®] Pasa-Jell 102 is left on the surface too long. This smut can be easily removed with a reapplication of Semco[®] Pasa-Jell 102 which should then be removed as soon as the smut disappears.

Semco[®] Pasa-Jell 102-M should be used for immersion treatment of large metal surfaces in tanks.

Note: Tank linings for Semco[®] Pasa-Jell products should be made of polyethylene or unplasticized polyvinyl chloride.

Storage

Semco[®] Pasa-Jell 102 and 102-M have a storage life of one year without significant loss of activity when stored in a cool, dry area in the original, unopened containers.
